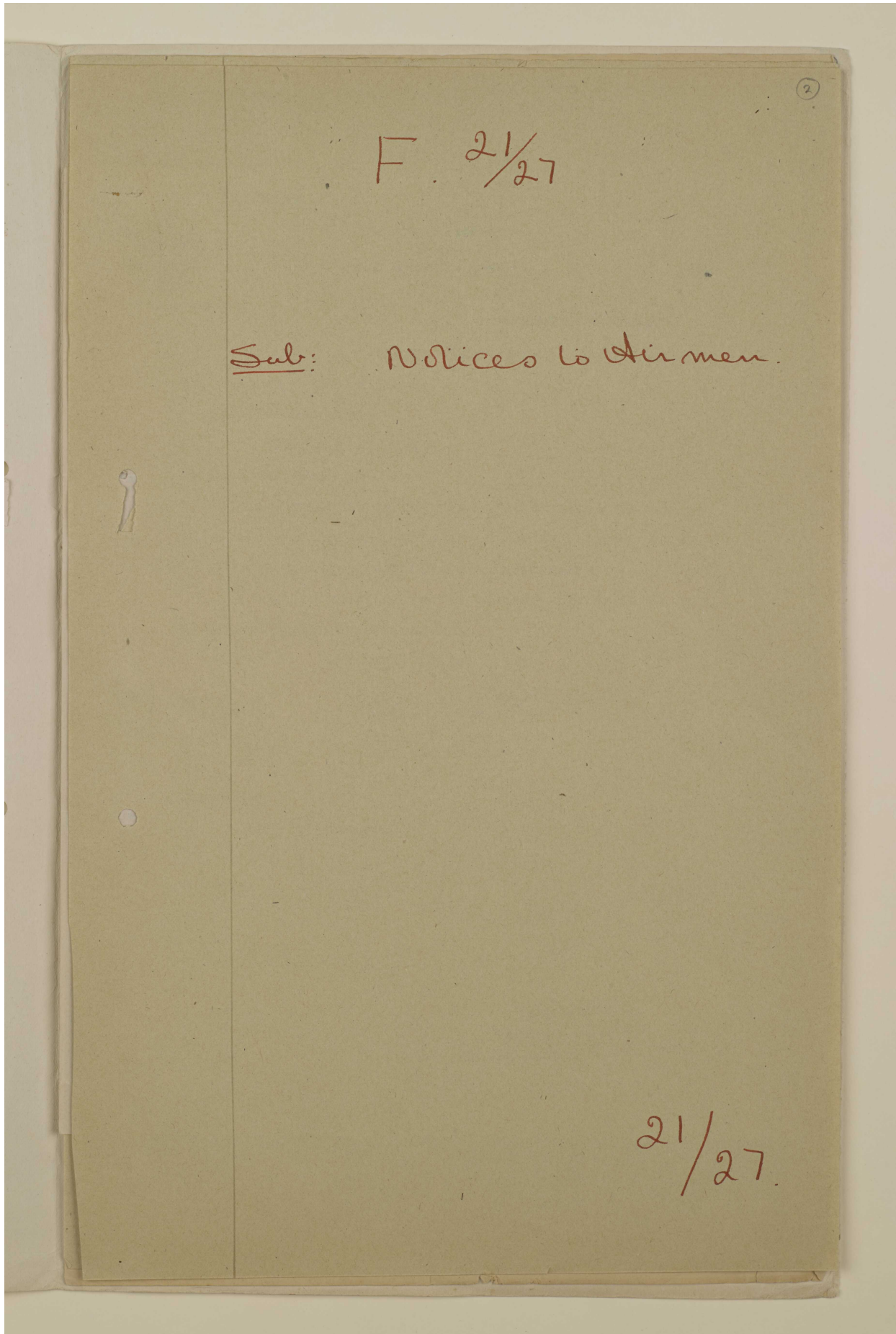

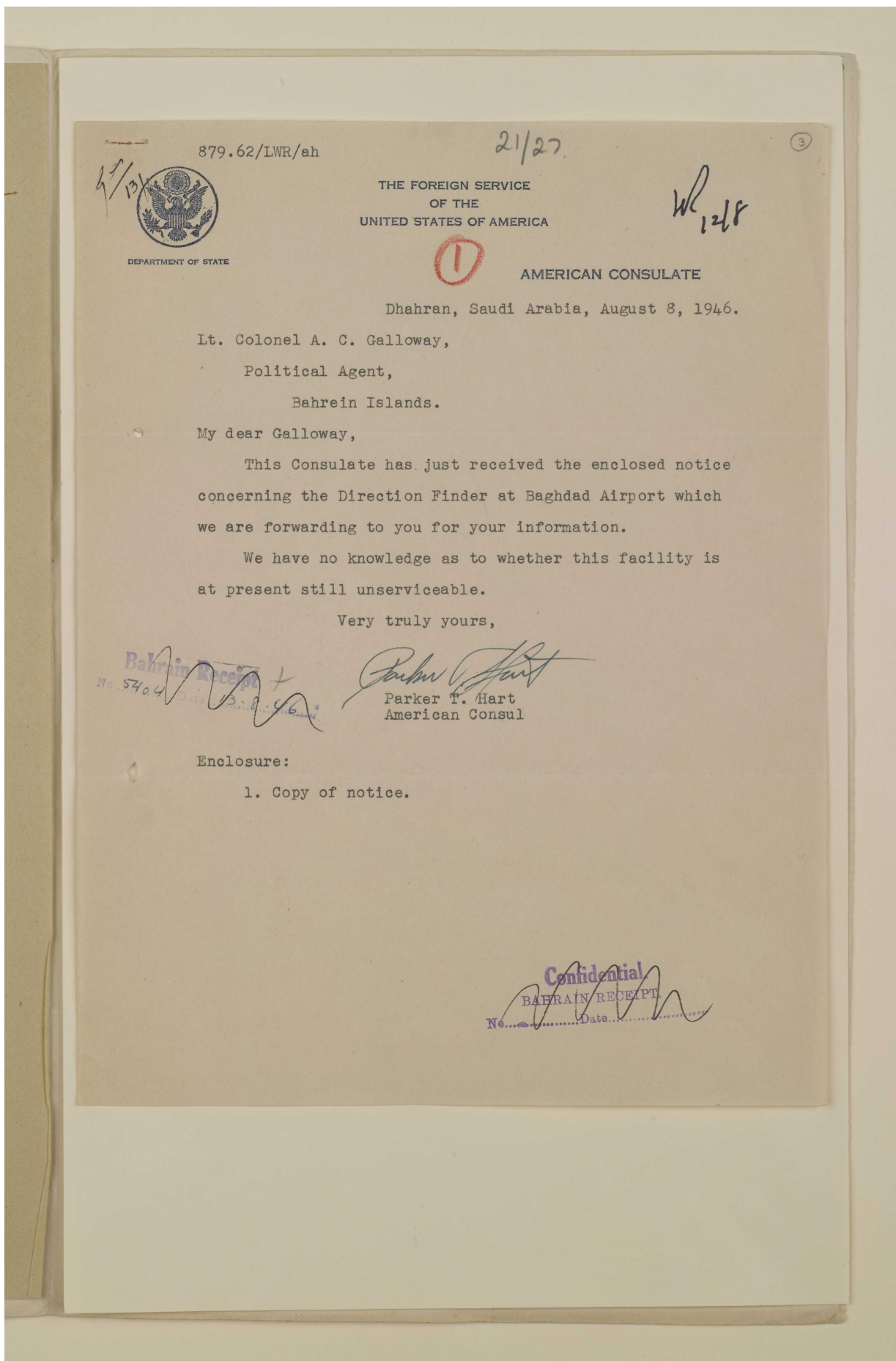

Following "Notice to Airmen" issued by Directorate of Civil Aviation on May 27, received today:

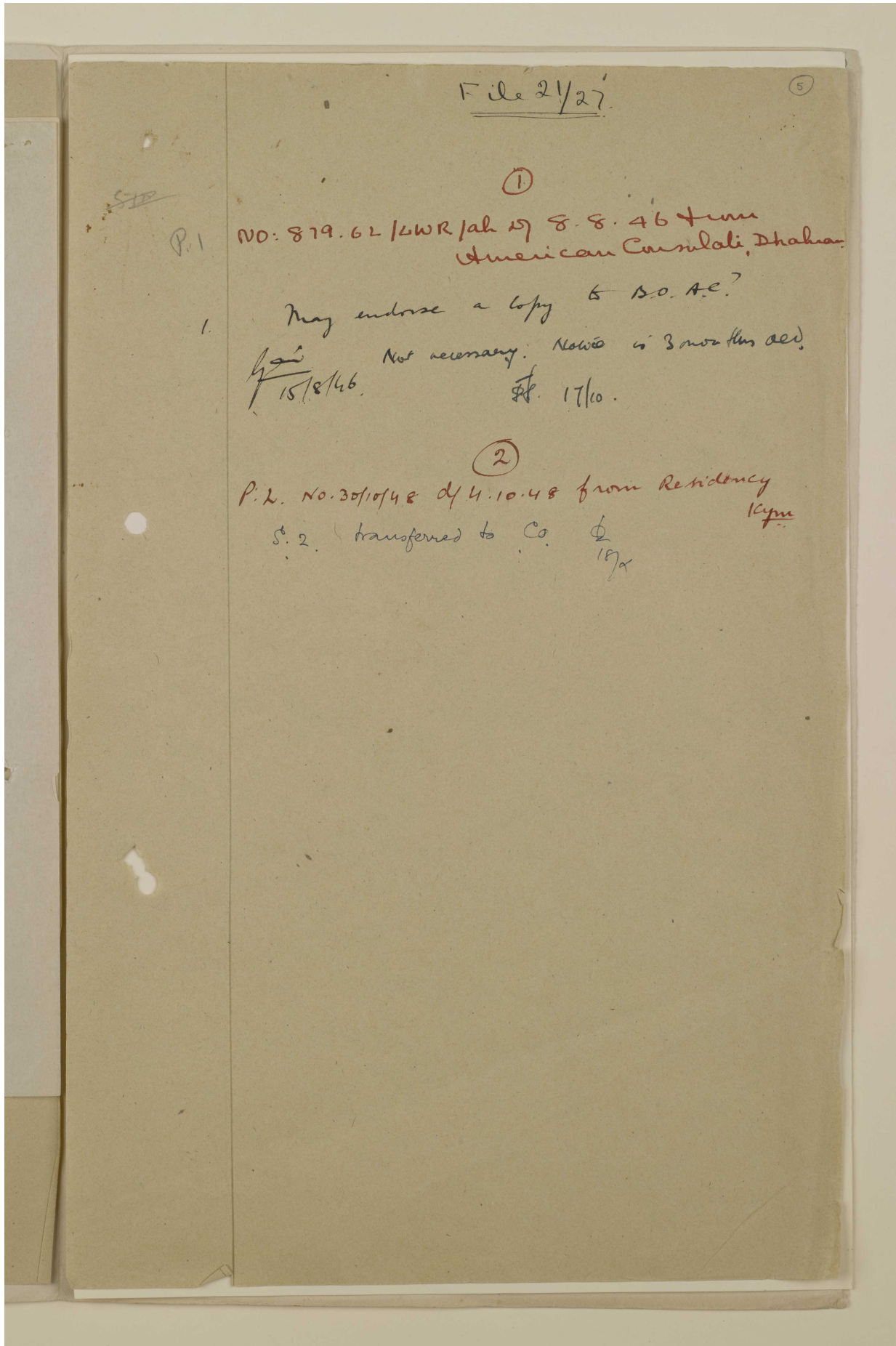
"It is hereby notified that the Bellini Tossi Direction Finder at Baghdad Airport has been declared unserviceable.

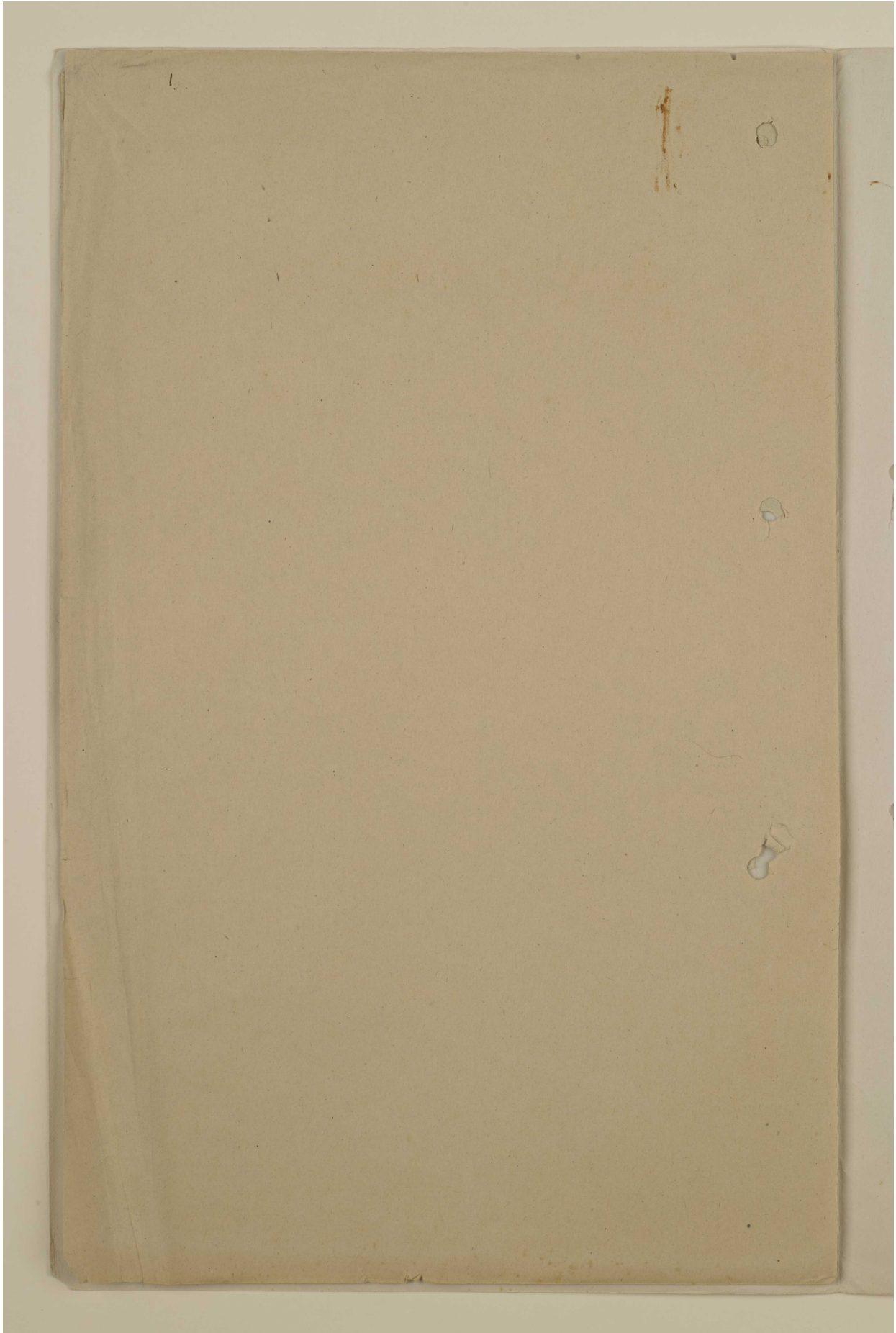

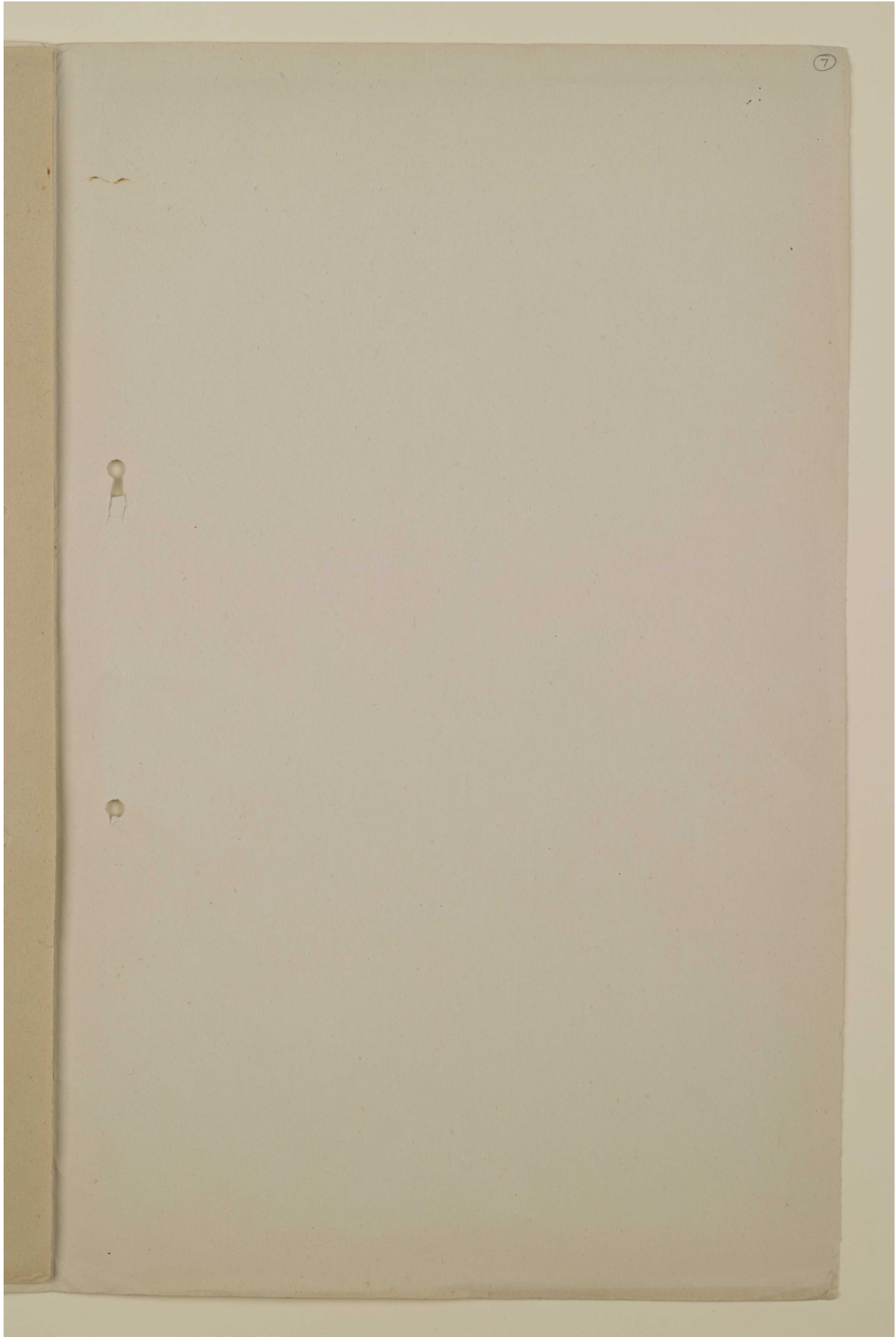
