The file consists of correspondence regarding a proposal for the certification of cash balances held by HM Consular Officers on behalf of the Government of India. This covers scenarios where consular officers obtained funds directly from the Government of India in advance of expenditure to be incurred on behalf of the Government. The proposal and arrangements for certification are discussed.

Correspondents include: the Foreign Office; India Office; Dominions Office; Colonial Office; and the Government of India, External Affairs Department.

The file includes a divider which gives a list of correspondence references contained in the file by year. This is placed at the back of the correspondence.
























































